

2010 VASWCD Educational Foundation, Inc. Scholarship Awards Program Guidelines

PURPOSE:

To promote the education of Virginia citizens in technical fields with natural resource conservation and environmental protection.

To give financial support to students majoring in or showing a strong desire to major in a course curriculum related to natural resource conservation and/or environmental studies.

CRITERIA:

Two Educational Foundation, Inc. scholarships will be awarded annually on behalf of the Virginia Chapter of the Soil and Water Conservation Society. One will be awarded annually on behalf of the VASWCD and one will be awarded annually on behalf of the VASWCD Auxiliary to an eligible individual nominated by Virginia's SWCDs.

Individual applicants must be full-time students enrolled in or who have applied to a *college freshman level curriculum*. Applicants shall document a class ranking in the top 20% of his or her graduating class or a 3.0 or greater Grade Point Average or appropriate equivalent of individual scholastic achievement. *The applicant's most recent official high school transcript must accompany the application. A copy of a school transcript will not be accepted.* Applicants shall demonstrate active interest in conservation.

Only one applicant per district may be submitted. Applications should be made from the county the student resides and attends school. Eligible applicants must reside within a local Soil and Water Conservation District.

It is the responsibility of the districts to screen applications for eligibility in accordance with the criteria stated herein. Applications not fulfilling minimum criteria shall not be considered.

AMOUNT AWARDED:

Four \$1,000 scholarships will be given to statewide winners. A check will be issued to the selected school in the student's name.

DEADLINES:

January 13, 2010	Application and guidelines distributed to SWCD Offices
March 3, 2010	Suggested Date Application must be returned to SWCD Offices
March 31, 2010	District's selected applicant with all supporting documentation must be received at the VASWCD Office
May 1, 2010	Scholarship award winners will be announced

Submitted applications will be reviewed and screened by the Scholarship/Awards Committee. All applications and information contained therein shall remain confidential. Nominations from the Committee will be submitted to the VASWCD Educational Foundation, Inc. Board of Directors for final approval.
